

WAIVER: RESPONSIBILITIES OF THE PARTICIPANT

I hereby declare that I DO NOT suffer from any congenital or acquired physical condition or injury that could affect my conditions of health or life, should I participate in the STAR WARS Run Singapore (hereinafter referred to as the "Race"). I also declare that before I register in the Race, and on the occasion thereof, I have had a medical check-up and I am in good physical condition capable of participating in it, and I also assume all risks associated with my participation in the Race (falls, contact with other participants, consequences of weather, traffic, road conditions or any other kind of risk that may be caused on the occasion of the Race or during it). I also specifically accept that I am participating in a sport that may result in physical injury as can any activity of such nature, and this has been assessed by the undersigned prior to registration in the Race.

I understand and voluntarily agree that Espresso Pte. Ltd., The Walt Disney Company (Southeast Asia) Pte. Limited, the sponsors and/or their controlling, controlled, contracted or associated companies do NOT take responsibility for any kind of indemnity, claim, cost, damage and/or prejudicial consequence claimed, including but not limited to damages from accidents or any material, physical, psychological or moral damage or lost profits caused to my person or to my dependents, because of and on the occasion of the Race in which I shall participate.

Having read this declaration and knowing these facts, I release Espresso Pte. Ltd., The Walt Disney Company (Southeast Asia) Pte. Limited, the sponsors and/or their controlling, controlled, contracted or associated companies and their representatives, authorities, directors and/or managers, shareholders and/or partners, of all and any claims or liability of any kind arising out of my participation in the Race as well as of any loss, theft and/or robbery that I might suffer. I also state that the entities and individuals mentioned shall not be liable for fires, short circuits, robberies, thefts, unforeseeable circumstances, whatever their cause, harm to my health as a result of quarrels or fights with third parties, harm to my health from physical or other conditions that might arise before, during or subsequent to the completion of the Race.

I also authorize and give my consent to Espresso Pte. Ltd., The Walt Disney Company (Southeast Asia) Pte. Limited and their associate, subsidiary, and controlling companies to use, reproduce, distribute and/or publish photographs, films, videos, recordings or any other recorded media of my person for promotional and/or advertising purposes, taken because of and on the occasion of the Race. In addition I give my consent to Espresso Pte. Ltd to share my personal data with the Walt Disney Company (Southeast Asia) Pte. Limited or its affiliates or with other third parties for administrative and business purposes, or for cross-promotion. This may involve the storage, use, disclosure or other processing, or transfer of your personal data out of Singapore. Third parties receiving your personal data will be bound by requirements under the Personal Data Protection Act 2012 in relation to your personal data.

I understand that Espresso Pte. Ltd., may suspend or extend dates without prior notice, and may even increase or reduce the number of registrations depending on the needs or on technical or structural availability. Espresso Pte. Ltd may suspend the Race for reasons of public safety, public acts, vandalism and/or reasons of unforeseen circumstance or force majeure and/or as demanded by a public authority. Espresso Pte. Ltd shall not reimburse the amount of the registration to participants who, for whatever reason, decide not to participate once they have registered. Participation in the Race implies my responsibility for the information provided, my full acceptance of these Regulations and payment of the registration fees. I recognize that athletes may not participate in the Race who are suspended or in respect of whom there may be proof of the use of prohibited substances, or who are subject to any kind of ban imposed by confederations or federations that is in effect at the time of the Race. Runners under the age of 18 years may participate in the Race provided the registration form has been signed by their parent or guardian.
